Pre-Purchase Exam Buyer Agreement

Exam

- Farm call Fee \$4.20/mile one way
- Physical exam with Lameness Eval/Flexions \$500

Laboratory Testing

- Blood chemistry and complete blood count \$95
- Drug screen for anti-inflammatories, steroids, and sedatives (10 day turnaround) \$534
 - 30 day blood holding fee that can be then ran for a drug screen \$25
- Fecal Parasite Test \$30
- Coggins \$54
- Health Certificate \$32

Imaging Requested

- Gastric Endoscopy (seller consent is required for this procedure) \$400
- Airway Endoscopy (seller consent is required for this procedure) \$200
- Digital Radiographs \$55 per view.
 - Farrier views (2 views each foot) \$110/hoof
 - Front feet with navicular (4 views each foot) \$220/foot
 - Fetlocks Front (4 views each) \$220/fetlock
 - Knees (carpus) (4 views each) \$220/knee
 - Fetlocks Hind (4 views each) \$220/fetlock
 - Hocks (4 views each) \$220/hock
 - Stifles (3 views each) \$165/stifle
 - Neck (4 views) \$220
 - Back (4 views) \$220
- Ultrasonography one site/region \$120

Radiographic Interpretation Options

- (1) I have my own veterinarian who will review any radiographs requested. Sunflower Equine Veterinary Clinic will not provide any written radiographic interpretation.
- (2) I would like the veterinary examiner from Sunflower Equine Veterinary Clinic to refer all radiographs for review by a boarded radiologist. Reports will be returned in 24 hours.





Consent and Acknowledgement

This purchase examination provides information about the horse's health and condition at the time of examination. It is the buyer's responsibility to inform the veterinarian of the extent of the examination and the selection of any diagnostic tests chosen. The examination is not to be used as a prognosis for future use, and findings are not a warranty, express or implied, or future health, soundness or suitability. The veterinarian's role in the examination is not to pass or fail the horse, but to help the prospective buyer make an informed decision considering the horse's overall health and soundness at the time of examination. The decision on whether to purchase the horse examined is solely the buyer's choice and responsibility.

The buyer should understand that there are limitations to a purchase examination and certain conditions may not be detectable by clinical, radiographic, ultrasonographic, and/or laboratory examinations on the day of examination. The buyer acknowledges that the veterinarian is not liable for conditions that may present in the future that could affect performance or resale, and this agreement is to release, waive, discharge and dismiss Sunflower Equine Veterinary Clinic and all employees from any claims arising directly or indirectly from the performance of the purchase examination.





Current Patient of the Practice

In the case where the horse in question is a **current patient** of a veterinary practice, it is required that the seller provide all **medical records** to the buyer. The intent behind this disclosure is to ensure transparency, protect the welfare of the horse, and enable the buyer to make an informed decision. This disclosure will include:

- **Veterinary History**: Any past treatments, surgeries, or medications the horse has received.
- **Diagnostic Records**: Information regarding any diagnoses or conditions the horse has been treated for, including chronic issues or recurring problems.
- **Current Conditions**: If the horse has an ongoing medical issue or requires continued treatment, this should be clearly documented.
- Vaccination and Health Status: Current vaccination status, deworming history, and any preventive care treatments.
- **Previous Injuries**: Details of any past injuries, their treatments, and whether there are any long-term effects.
- **Laboratory Results**: Blood work, radiographs, or any other diagnostic testing that has been performed.
- **Medications and Supplements**: Any current medications or supplements that the horse is on, including their purposes and dosages.

Payment Agreement

- A \$500 deposit is required prior to the appointment for out of state buyers.
- Remaining balance of the appointment will be charged at completion of the exam with the card already tokenized on file with the deposit.
- If payment is declined, a 1.5% finance charge will be applied to each invoice for every 30 days it is overdue. After 30 days all accounts are subject to collection proceedings and further services will be discontinued. The client shall be solely responsible for the outstanding balance due, late fees, interest charges, all reasonable attorneys' fees and court costs incurred by Sunflower Equine Veterinary Clinic associated with any collection efforts.
